## **SKATEBETTERNOW**

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

I \_\_\_\_\_\_\_acknowledge that the sport of roller and inline skating is a high risk activity and understand that I could receive bodily injuries including (but not limited to): bruises, abrasions, pulled muscles, broken bones, concussion, and even death. I hereby represent that (i) I am in good health and in proper physical condition to participate in the activities related to roller and inline skating; and (ii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the activities related to roller and inline skating. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the activities related to roller and inline skating.
- 2. I understand and acknowledge the physical and mental rigors associated with the activities are inherently dangerous and represent an extreme test of a person's physical and mental limits and condition. I understand that participation in the Activities involves risks and dangers which include, without limitation, the potential for serious bodily injury, sickness and disease, permanent disability, paralysis and loss of life; loss of or damage to equipment/property; exposure to extreme conditions and circumstances; accidents, contact or collision with other participants, spectators, fellow skaters, or natural or manmade objects; dangers arising from adverse weather conditions; imperfect conditions existing on the property where the Activities take place; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the organizers of the activities related to roller and inline skating; and other undefined risks and dangers which may not be readily foreseeable or are presently unknown (the "Risks"). I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the activities related to roller and inline skating, or the acts, inactions, or negligence of the released Parties. I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses, which I incur as a result of my participation in the activities, related to roller and inline skating.
- 3. I agree to be familiar with and to abide by all rules and regulations established for the activities related to roller and inline skating in which I participate. I also accept sole

responsibility for my own conduct and actions while participating in these Activities and the condition and adequacy of any equipment that I might own and supply in conjunction with those Activities.

I hereby release, waiver, and covenant not to sue, and further agree to indemnify, defend and hold harmless the released Parties, together with the organizers, promoters, sponsors, advertisers, hosts, venue and property owners upon which the activities related to roller and inline skating take place, law enforcement agencies and other public entities providing support for the Activities, and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders, members, agents, employees and volunteers, with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense, including court costs and reasonable attornev's fees of any kind or nature ("Liability") which may arise out of, result from, or relate to my participation in the activities related to roller and inline skating, including claims for Liability caused in whole or in part by the negligence of the released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, make a claim for Liability against any of the released parties, I will indemnify, defend, and hold harmless each of the Released Parties from any such Liability which any may be incurred as a result of such a claim. I hereby warrant that I have read this Agreement carefully, understand its terms and conditions, acknowledge that I will be giving up substantial legal rights by signing it (including the rights of the minor, my spouse, children, parents, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns), acknowledge that I have signed this Agreement freely and voluntarily, without any inducement, assurance or guarantee, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions and provisions of this Agreement. This Agreement represents the complete understanding between the parties regarding these issues and no oral representation, statements, or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
